Miss Tombigbee Scholarship Pageant
Contestant Contract

1. Scholarships shall be intended for tuition, room and board and other education expenses.
2. Scholarship awards are verified and confirmed upon receipt of a letter of acceptance from the contestant. This letter of acceptance should be received within 30 days after the award notification. Failure to submit this letter within the 30-day period will result in forfeiture of award. The letter must be received in our hands on or before August 11, 2011 at 5:00 pm via The Miss Tombigbee Scholarship Pageant, Post Office Box 1289, Livingston, Alabama 35470 or in person.
3. Request for scholarship awards are processed upon receipt of statement from the college or university (Make sure you send in your acceptance letter even if you do not have a statement from the college or university). All statements must be accompanied by a cover letter from the contestant.
4. The Miss Tombigbee Scholarship Program has 1 year from the receipt of the letter of request to pay the scholarship to the school.
5. Request for payment for other educational expenses must be pre-approved by the Miss Tombigbee Scholarship Pageant Executive Director.
6. Cash awards may be used for outstanding student loan obligations provided the loan is not in default and provided the contestant has completed the course work for which the loan was obtained. Notice of payment due must be submitted to the Miss Tombigbee Scholarship Program.
7. Contestant must begin to use their award within one year from the date of the award. If contestant has no activity in her award account during this period, the funds in her account will be forfeited.

8. Cash awards, which have been forfeited, will remain in the scholarship account of The Miss Tombigbee Scholarship Program for future awards.
9. Contestants who are college graduates and who do not intend to pursue any further college education may elect to receive their award in the form of an U.S. Savings Bond. In order to reserve this award, the contestant must send a written request along with a copy of their college degree or equivalent certificate to the Miss Tombigbee Pageant Director. The denomination value of the savings bond will be equal to the total amount of the cash award.
10. No previous winner of the title of Miss Tombigbee can compete for that same title in the future (i.e. repeat winners).
11. Contestant who wins the title of Miss Tombigbee will be required to attend all Miss Alabama required meetings, orientations, workshops, and the Miss Alabama's Outstanding Teen Pageant (if required by Miss Alabama to attend). The new Miss Tombigbee will be required to get approval from the Miss Tombigbee Pageant Director on all competition clothing for the Miss Alabama Pageant. Miss Tombigbee will also be asked to make appearances throughout her year of reign and will be required to be at the next Miss Tombigbee Pageant to crown her successor. She must visit a minimum of 5 schools during the year and at least one of these schools must be in the Livingston area. She must be willing to be in the Christmas on the River Day Parade the first Saturday in December. Miss Tombigbee will be willing to speak before the Livingston City Council, the Sumter County Commission, the Greensboro Music Club, and the Livingston Primrose Club during her year of service. Failure to meet these requirements may result in forfeiture of scholarships or even the title of Miss Tombigbee.
12. Miss Tombigbee will participate in fund raisers for the Children's Miracle Network. It is the responsibility of Miss Tombigbee to raise her required \$250.00 to participate at Miss Alabama. Miss Tombigbee will also make at least 2 visits to volunteer at the Children's Hospital which is closest to your home and will make at least one appearance at the Children's Hospital of Alabama in Birmingham.
13. Any Contestant who must forfeit the title of Miss Tombigbee will be required to reimburse the Miss Tombigbee Pageant for any monies or scholarships already awarded. They must also return the official Miss America Local Crown, Crown Pin, and Scepter so these items can be given to the runner up who assumes the title. The runner up who assumes the title of Miss Tombigbee as a result of forfeiture will receive all prizes and scholarship monies as soon as the Miss Tombigbee board can secure those from the previous title holder. In the event Miss Tombigbee wins the title of Miss Alabama we will not crown a successor. She will just be considered to have held the title of Miss Tombigbee for her entire reign.

14. I agree to hold harmless the Miss Tombigbee Pageant and that neither Miss Tombigbee Director nor volunteers, nor the sponsors of Miss Tombigbee, nor anyone working for or with this pageant be held liable should any accident occur during any rehearsals or during the pageant activities. I agree that neither Miss Tombigbee Director or volunteers, nor the sponsors, nor anyone working for or with this pageant shall be held liable should any theft or destruction of my personal property occur during any rehearsals or during the pageant activities, except for the perpetrator of said theft or destruction.
15. I maintain that I am eligible for the title of Miss Tombigbee by claiming residence (verifiable address, home or school), work (have a check stub within the last 6 months), or school (proof of registration) in one of the 25 counties of the state of Alabama that is within the Miss Tombigbee Coverage area. I also must be able to qualify to compete in accordance with the Miss Alabama and Miss America Contracts.
